## FANTASYLAW 2009

## The Season, the Stars, and the Statistics

## The Editors

Afew weeks ago we wrapped up the first season of FantasyLaw, which was held during the first session of the 111th Congress of the United States. What follows below is a summary of the statistical performances of each member of Congress during that season, plus comments on a few highlights. We would like to think that this report will prove useful not only to people who are trying to win in FantasyLaw in 2010, but also to people who are trying to understand the behavior of legislators and the worlds in which they work. More realistically, perhaps, we hope that as ever-more-complete-and-comprehensive sequels to this report follow in the years to come, the resulting pile of information will eventually reach some kind of critical mass. Then, students of Congress will be able to find some useful insights into the ways and means of our national legislature and the people who work in it.

## The Season

Our season began on July 6, 2009 (long after the 111th Congress convened on January 6), and ended on November 1, 2009 (long before Congress adjourned on December 24). The short season was really a shakedown cruise in which the only Team Owners were friends of the Green Bag who agreed to to form Leagues in order to help us work out kinks in the game. They did a good job, we made some fixes, and now we think we have both a viable design for the game itself and a functional backroom operation to support it. And so we have opened up FantasyLaw just a bit to the public for 2010. We are looking forward to an interesting season this year, and an even bigger and better one in 2011.

## The Stars

TThe last gasp of the 2009 season was the first annual FantasyLaw Awards Ceremony, which we held on January 12, 2010 at the George Mason University School of Law. Sarah Nash presided, and opened the event by welcoming the audience and recognizing her fellow FantasyLaw editors in attendance (Brendan Coffman, Alex Mitchell, and Joshua Cumby) and absent (Lauren Girardot, Emily Christine Kendall, Daniel Klionsky, and Brian Rock). Cumby then delivered a short speech, which went something like this:

In Federalist No. 64, John Jay remarked on the motivations of members of the United States Senate: "With respect to their responsibility, it is difficult to conceive how it could be increased. Every consideration that can influence the human mind, such as honor, oaths, reputations, conscience, the love of country, and family affections and attachments, afford security for their fidelity."

To this list we can now add the enticement of former and future glory on the fields of FantasyLaw, " $[\mathrm{t}]$ he fantasy sport where the players are lawmakers."

Welcome, everyone, to the First Annual FantasyLaw Awards Ceremony. Just over a year ago, Green Bag Editor-in-Chief Ross E. Davies gathered a rag-tag group of erstwhile but eager law students in his office, and together they embarked on a journey whose ultimate destination was (and is) only faintly discernible. They knew that playing a fantasy-style sport with Federal legislators was a
great idea. They also knew that the sport's practical and academic applications were, well, limitless. And, like all other Green Bag projects, they knew FantasyLaw would be both purposeful and fun.

As the contours of the project began taking shape during "betatesting," all of the editors' expectations in these and so many other regards were met and exceeded. To keep tabs on the U.S. Congress, FantasyLaw editors "enacted" an alphabet soup of scoring measures that rivals anything seen during (or since) the New Deal. Some of the first scoring categories are already timeless - bills introduced, reported, and passed, appearances in major publications and the mass media - while others had to be left behind or safely stored for revival in future seasons. (No, they're not telling.) Once a working system was in place, it was time to take the show on the road (or at least the information superhighway). The 2009 Season began on Opening Day, July 6, 2009, and culminates today in our first FantasyLaw Awards Ceremony. The work was hard but the tears were few, and thanks goes out to all of those who so valiantly volunteered to play during FantasyLaw's Inaugural Season. The Editors hope you had fun (they certainly did). They also hope that the literature FantasyLaw will continue to inspire and the faithfully collected data that is its lifeblood will be useful to players past, present, and future, as well as wonks, la-z-boy legislators, and all others who have an interest in the inner workings of the ceaselessly fascinating democratic institution that is the United States Congress. After all, as Yogi Berra famously intoned, "You can observe a lot just by watching." Thank you.
Coffman then presented Blackmun Trophies ${ }^{1}$ to the champions of the four Leagues participating in the 2009 FantasyLaw season:

- In the Galloping Gophers League: Snack Cakes, with a season score of 683.5.
- In the Justice League: The Voting Elvii, with a score of 586.
- In the Pro Se League: The Philly Busters, with a score of 621.
- In the Stimulus Spending League: Speech or Debate Claws, with a score of 583.5. (The Stormin' Normans were co-champions.) ${ }^{2}$

Blackmun Trophies were also presented to the 2009 FantasyLaw MVP Award winners:

- In the House of Representatives: Nancy Pelosi (D-CA), with 2961.35 average points per week. Barney Frank (D-MA) came in second with 2862.
- In the Senate: John McCain (R-AZ), with 689 average points per week. Patrick Leahy came in second with 658.147. ${ }^{3}$
Congratulations to all on a successful and enjoyable first season.

## The Stats

Now to the statistics. The tables on the following pages present the basic statistical record of each person who served in the Senate or the House of Representatives during the first session of the 111th Congress, as measured by the eleven FantasyLaw measures of legislative performance. A key to "The Eleven Measures of FantasyLaw Performance" and their acronyms is below. The names are pretty much self-explanatory, but the details of our methods for gathering the data and our standards for what does and does not count in each category are not. A complete explanation is available in our "Scoring System" pamphlet, which is available at the "Rules, tools, and forms" link on the FantasyLaw website. ${ }^{4}$

When studying these statistics, please bear in mind that the FantasyLaw season began on July 6 and ended on November 1, 2009, and thus covered less than one half of the first session of the 111th Congress, which worked off and on from January 6 to December 24, 2009. As a result, our numbers provide only a partial picture of

the work of each federal legislator. This means, for example, that some legislators (those who were especially active during the summer and early autumn) might appear to have been more engaged than they really were over the course of the entire year, while others (those who might have been especially active early and late in the session) might appear to be less engaged. For example, Senator Jim Bunning's line in our report seems to show that his entire involvement in the legislative process during 2009 consisted of sponsorship or co-sponsorship of a single bill that was not enacted, and a single appearance in the Congressional Record. But it may be that he was active in other legislative work before July 6 and after November 1. So, make of these statistics what you will, but do not make more of them than what they are. ${ }^{5}$
